Based on the discussion held during National Review of NRDWP held on 25.08.2014, followings are being conveyed to the States / UTs for achieving Swachh Bharat by 2019.

2. Very low progress in respect of construction IHHL has been noted in most of the States. **It has been decided that States must have plan for Sanitation (which includes construction of IHHL, School and Anganwadi toilets and Community Sanitary Complex) before approval of any new Water Supply Scheme by SLSSC for the rural habitation.**

3. It has been noted that States are giving coverage to Fully Covered habitations even though substantial numbers of Partially Covered and Quality Affected Habitations are yet to be covered. Hence, **it has been decided that States must cover first all Partially Covered and Quality Affected Habitations for providing at least 40 LPCD before going for additional coverage (beyond 40 LPCD) to already Fully Covered Habitations.**

4. States / UTs must ensure implementation of the above decisions. Respective Area Officers shall also ensure this while approving proceedings of SLSSC.
