The undersigned is directed to refer to Committee on Government Assurances, Lok Sabha Secretariat O.M. No.12/1/PS/2014-CGA dated 18.11.2014 regarding fulfilling of assurances given in respect of Lok Sabha Unstarred Question No. 3665 replied on 13.2.2014 asked by Shri Hamidullah Sayeed regarding Bio Toilets to intimate that for fulfilling the assurance information from all Sates/ UTs and DRDO was required, hence, this Ministry vide letter dated 28.2.2014 and dated 4.3.2014 had requested all States/UTs and DRDO respectively to provide information in respect of (c), (d) and (e) part of the Question from States/UTs and part (a) and (b) from DRDO. Information was received from few States and reminders were issued to States /UT who had not provided information on 11.3.2014, 5.5.2014 and 21.5.2014.

- 2. As information from all States/UTs has not been received, hence, assurance given could not be fulfilled. Due to dissolution of the 15<sup>th</sup> Lok Sabha and after elections constitution of 16<sup>th</sup> Lok Sabha, there was some confusion and extension for fulfilling the assurance could not be taken. Delay in this regard is regretted.
- 3. Information received from DRDO in respect of part (a) and (b) is at Annexure-I and in respect of part (c), (d) and (e), State/UT wise information received so far is at Annexure-II.
- 5. As information from States is yet to be received, it is, therefore, requested that extension of time up to 15<sup>th</sup> January, 2015 for fulfilling the assurance may kindly be granted.

Approval of the Hon'ble MOS for Drinking Water and Sanitation has been obtained.
