Sir,

This is with reference to the Village Water Security Plan received from Ananthapuram district, for the Gram Panchayat Mallapalle in Gorantla Mandal. Ministry had examined the Village Water Security Plan, from your State, for which the comments and suggestions is given below:

- The Village Water Security Plan received for Gram Panchayat Mallapalle in Gorantla Mandal does not appear to be in tandem with the Model VWSP. Please refer the Model VWSP (Available at MDWS website) and resubmit after revising and correcting all the mistakes including spelling and grammar.
- 2. The total cost appears to be very high (Rs.3.96 Cr) for a GP containing 8 habitations with 922 House Holds. As per the Concept Note the rough cost allowable is Rs. 30 lakhs/GP containing 150 House Holds. In this case the GP consists of roughly 6 –times more House Holds (150 X6) and maximum permissible limit would be 180 lakhs.
- 3. There is an existing piped W.S.S in the village with 362 House Hold connections with 40,000 liters tank, apart from this there are 4 –GLSR. In this proposal it is mentioned that water supply improvement scheme (New scheme) at a cost of Rs. 1.999 Cr is proposed. What is the deficiency with the existing piped water supply scheme is not explained. As such no justification is given.
- 4. In the Water Budget Estimation the Drinking & Domestic water being supplied should be indicated. Whereas the requirement as per designed norms is arrived and shown in the calculation of water Budget which is not correct? This can be shown in the water budget estimation that may result after implementation of the water security plan.
- The water balance estimation (Expected water balance) that may result in after implementing water security plan is not furnished.

- 6. How the ODF can be achieved /ensured is also not elaborated.
- 7. Action Plan with time lines is not enclosed.

Kindly incorporate the above suggestions and send it by 15th of Oct 2014.
