Service, Educational Qualification and Experience required for Assistant Adviser (PHE)

2. In terms of the notified Recruitment Rules for the post of Assistant Adviser (PHE) the educational qualifications, experiences and age limits etc. required for the post shall be as under:

Officers under the Central or State Governments or Union Territories or Autonomous Bodies or Public Sector Undertakings or Statutory Organizations or Universities or Recognized Research Institutes:

- A. (i) Holding analogous posts on regular basis in the parent Cadre/Department; or
 - (i) with 5 years' service in the grade rendered after appointment thereto on a regular basis in PB-3, Rs. 15600-39100/- + 5400 Grade or equivalent in the parent cadre or Department; or
 - (ii) with six years' service in the grade rendered after appointment thereto on a regular basis in PB-2, Rs. 9300-34800 + 4800 Grade Pay or equivalent in the parent cadre or Department; and

- B. Possessing the following educational qualifications and experience:\
 - (i) Bachelor's Degree in Engineering/Technology in Civil Engineering/Environmental Engineering/Public Health Engineering from a recognized University; and
 - (ii) five years' experience in isolation or collectively in investigation or design construction or operation of water supply and sewerage installation including one year in urban sector or rural sector with experience in desalination/ de-fluoridation/ iron removal/ water harvesting structures in Government or Autonomous or Semigovernment organization or private organization.
- 3. Period of deputation (including short-term contract)/absorption including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (including short-term contract) shall not be exceeding 56 years as on the closing date of the receipt of applications.

Note: For the purpose of appointment on Deputation/Absorption basis, the service rendered on a regular basis by an officer prior to 1-1-2006 or the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.

- 4. It is, therefore, requested that service particulars and bio-data of the eligible officers who are willing to be considered, may please be sent to this Ministry in the prescribed Proforma (in triplicate) enclosed (Annexure-I) along with their compete and up-to-date CR Dossiers and Vigilance Clearance, Integrity Certificate and No penalty certificate (Annexure-II) and in case any major/minor penalty has been imposed during the last 10 years in the prescribed format as at Annexure II, so as to reach this Ministry latest by 45 days of publication of this circular in the Employment News/Rojgar Samachar and in National dailies viz Times of India, The Hindu, Hindustan Hindi, Dainik Jagaran, and DNA. - 5. While forwarding the applications of the officers, it may also be certified that the service particulars of the officers have been checked and found correct as per records available with them and a certificate in this regard may also be sent to this Ministry. The applications received without complete and up-to-date CR Dossiers, vigilance and integrity certificate and a list of major/minor penalties of the officers will not be considered. Once the nominations of the officers are received, they will not be allowed to withdraw their nomination later.
