Sir/ Madam,

- 1. As you are aware, the South Asian Conference on Sanitation (SACOSAN) have been a platform for the Government, practitioners and professional agencies and Civil Societies to engage in constructive dialogue for collective effort to foster regional collaboration in pursuit of meeting the sanitation challenge in the region.
- 2. The first South Asian Conference on Sanitation was held in Bangladesh in 2003 and the subsequent ones hosted by Pakistan (2006), India (2008), Sri Lanka (2011) and Nepal (2013). The Government of Bangladesh is organizing in the 6th SACOSAN Conference in Dhaka Bangladesh from 11th-13th January, 2016. The Conference is being organized in close cooperation with the SACOSAN Inter-Country Working Group, consisting of sanitation focal person from all member countries.
- 3. India is requested to send a delegation to SACOSAN-VI to be held in Dhaka from 11^{th} - 13^{th} January, 2016. The Indian delegation is to consist of officials from Government of India, some State Governments representing PRIs and also some good NGOs.
