Please refer to this Ministry letter of even number dated the 27.01.2015 informing about the amendment dated 23.01.2015 to NRDWP guidelines by adding a new sub-paragraph 15.9 to para 15 (Planning) according to which, proposals under the SAGY were to be given utmost priority. It was further informed vide DO letter of even number dated 29.06.2015 that provision of potable drinking water in the Gram Panchayats under the SAGY are allowed by taking up new schemes or through augmentation of existing schemes.

All the States/UTs are hereby requested to plan such schemes and get it approved through the respective SLSSC by end of December 2015 and ensure execution of the schemes on top priority. For expeditious action, meeting of SLSSC may be held and minutes of the meeting may be sent to the concerned Area Officer (designated by this Ministry) for their information/consent.

In this regard, a Video Conference has been convened on 07.12.2015 as per schedule attached. The Video Conference will be jointly taken by Joint Secretary (Water), MDWS and Joint Secretary (SAGY), Department of Rural Development, You are hereby kindly requested to attend the Video Conference along with the concerned officers with current status of piped water supply and ongoing schemes in SAGY-GP
