DISCUSSIONS

With the permission of the Chair, Dr. NipunVinayak, Director, SBM(G), welcomed all the participants and initiated the discussion on the agenda points of SACOSAN VI preparations.

Agenda 1: Discussion on first draft of India country paper for the SACOSAN-VI by UNICEF.

Mr. Sujoy Mojumdar, from UNICEF made a presentation, in which he outlined on the contents and explained in brief on the draft Country Paper. The Country paper was prepared based on the template suggested by the SACOSAN VI Secretariat. After discussions it was agreed that the Country Paper would be circulated to all the partner agencies, who, thereafter, will submit their comments, if any, by 23.11.2015.

Agenda 2: Discussion on technical focus session (TFS) for R & D, Innovation abstracts received from the experts/officials/other for SACOSAN-VI

Mr. G.Balasubramanian, Deputy Adviser, informed that 2 full texts and 1 draft full text of selected technical paper has been received for the Technical Session presentation. On receipt of paper from World Bank, all the papers will be forwarded to SACOSAN VI Secretariat. Bhutan selected one paper from India under the theme *Gender, Equity and Right (GER)* and Nepal selected one paper under the theme, WASH in Institutions and Public Places.

Agenda 3: Composition of Indian delegation to participate in SACOSAN-VI and sponsorship of delegation by regional partners.

It was apprised that the Indian delegation will consist of 80 members comprising 4 from MDWS, 6 from other Ministries, 54 from States and 16 from partner agencies.

The delegation comprises of Govt. officials, non-officials significantly associated in the promotion of sanitation, and sanitation champions including women, adolescents disabled etc. The partner agencies indicated the number of participants from their organization, as well as the number of participants they can sponsor. They were informed that the decision of the Ministry in this regard will be informed within a week.

Agenda 4: Discussion of side events of SACOSAN-VI.

It was decided that two side events of SACOSAN-VI will be organized by India. Side event on *Menstrual Hygiene Management (MHM)* will be organized by WSSCC. The side event on *SBM* will be organized by WSP/World Bank with the support of CLTS Foundation. The concerned partner agencies were asked to send programme design of the sessions by 23.11.2015.

Agenda 5: Discussion of Exhibition of SACOSAN-VI

The exhibition will be jointly organized by Water for People and WASH Institute. They were asked to submit draft exhibition design by 23.11.2015. They were also asked to include flyers/brochures in discussion with JD(Statistics), MDWS.
