- 1. Scope of work: Wooden flooring with good quality reputed branded materials in the conference room of the Ministry at 4th Floor, Pt. Deendayal 'Antyodaya Bhawan', CGO Complex. New Delhi.
- 2. Eligibility conditions: The bidder should have an experience of at least 2 years or more in this field. List of Customer along with the details of contact person, Tel. Nos Fax, and complete address may be given.
- 3. Earnest Money Deposit (EMD): The bidder shall furnish an amount of Earnest Money of Rs.5,000 (Rupees Five Thousand only) by way of Demand Draft drawn in favour of "DDO, Ministry of Drinking Water and Sanitation" payable at New Delhi. The bid security of the unsuccessful bidder will be discharged/returned subsequent to the award of Contract.

### 4. Submission of Tenders:

(i) The quotation indicating rate for entire work to be given (including all expenses like labour charge etc.)

(ii) The rates should be mentioned in figures as well as in words exclusive of taxes and levies.

(iii) The quotation along with an envelope containing EMD is to be kept in a big sealed envelope.

(v) The sealed envelope containing all bids must be delivered to the Under Secretary (Gen.), 8th floor, Pt. Deendayal 'Antyodaya Bhawan', CGO Complex, Lodhi Road, New Delhi on 22nd December, 2016 at 1500 Hours.

(vi) The bids shall be opened on same day at 1530 Hrs. in the presence of authorized representatives of bidders.

(vii) Late/delayed tenders due to any reason, whatsoever, will not be accepted/considered, at all, under any circumstances.

- **5. Pre bid meeting:** Pre-bid meeting will be held on 20th December, 2016 at 3.00 PM for clarification of work, quality and any other details of the requirement.
- **6. Onsite warranty:** Successful bidders shall undertake an onsite warranty for a period of three years. All the cost for repair for any natural defects on the wooden floor within warranty period shall be borne by bidders

#### 7. Performance Security:

(i) The successful bidder shall be required to deposit an amount up to 10% of the contract value within 15 days of issue of letter of intent, as Performance Security. The exact amount will be determined and conveyed to the successful tenderer.

(ii)Performance security shall be submitted in the form of Demand Draft drawn in favour of DDO, Ministry of Drinking Water and Sanitation" payable at New Delhi and shall be valid for at least 60 days beyond the date on which the contract is to terminate.

- (iii) If the contractor fails or neglects any of his obligations under the contract, Ministry of Drinking Water and Sanitation reserve the right to forfeit either whole or any part of Performance security furnished by the bidder as penalty for such failure.
- 8. Payment: Payment to the successful bidder shall be released after successful installation of wooden flooring.
- 9. Validity of Tender: Rates quoted by the Firm shall remain valid for a period of 90 days or more.
