QUALIFICATION CRITERIA

1. Should have authorization of Sony brand TVs for supply of SONY products.
2. Interested persons may inspect the location and obtain the tender documents from the office of the Under Secretary (General), Ministry of Drinking Water & Sanitation, 8th Floor, Pt. Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi- 110003 during normal office hours on all working days from 20.01.2017 to 31.01.2017. Tender may also be downloaded from Ministry website www.mdws.gov.in under the head Tender news.
3. A complete set of tender documents may be collected from the above office during the normal office hours on all working days from 20.01.2017 to 31.01.2017.
4. All completed tender documents in two parts 'A' and 'B' should be submitted on or before 3:00 pm on 31.01.2017 along with Earnest Money Deposited of Rs. 30,000/- (Rupees Thirty Thousand only) by way of DD/Bankers Cheque in favour of "**PAO Ministry of Drinking Water & Sanitation**" drawn on a Nationalized Bank payable at New Delhi, in separate covers, failing which tender will be rejected. Part 'A' of the tender containing requisite pre-qualification criteria and EMD will be opened on **31.01.2017 at 3:30pm**. The date of opening of Price bid in part 'B' will be advised subsequently.
5. Conditional tender will not be accepted.



CONDITIONS OF CONTRACT

The tender terms and conditions for submitting the tenders are as follows:-

1. The tenders should reach at this office during office hours not later than 3:00 pm on 31.01.2017 duly sealed and superscribed with the name of the project / work.
2. The tenders will be opened on 31.01.2017 at 3:30 pm in the Conference Room of Ministry of Drinking Water & Sanitation at 4th Floor, in presence of those contractors or their authorized representatives who desire to remain present.
3. The supply including installation should be completed within a period of 6 days from the date of work order.
4. Unsealed tenders will not be accepted.
5. The rates should be quoted both in figures and words. In case of discrepancy in the rates in figures and words, the rates in words will be considered for evaluating tender.
6. Tenders with any conditions, additions / alternations, omissions, overwriting etc. will not be accepted. Corrections, if any, should be duly signed and stamped.
7. All the materials to be used for installation of TV should be of the best quality.
8. The rates to be quoted shall be fixed, inclusive of all charges, taxes, transportations, octroi duty, sales tax / VAT, excise duty etc. No additional payment will be made towards these on any account.
9. The Ministry reserves the right to reject all or accept any tender without assigning any reason thereon;
10. The tenders to be submitted must be strictly in the format as per the enclosed schedule, failing which the tender will be rejected.
11. The tender rates should be valid for a period of 3 months from the date of opening.
12. Earnest Money Deposit of Rs. 30,000/- (Rupees Thirty Thousand only) shall be deposited with the Ministry by way of Demand Draft as a guarantee of good faith for the proper execution of the contract along with the tender in favour of PAO Ministry of Drinking Water & Sanitation failing which tender will be rejected.

13. The contractor shall make his own arrangement for procuring all the materials required for execution of the above work and may store the same at site at his own risk & cost.
14. Removing debris from the site shall be contractor's responsibility at no extra cost.
15. The contractor should acquaint himself with the site conditions, local traffic regulations, local authority regulations, availability of materials, labour law rules etc. and quote the rates accordingly. No extra charges / increase in the rate shall be considered on any amount.
16. The rates quoted shall cover for execution of the work after office hours and on holidays and in stages.
17. The EMD / retention money shall not carry any interest.
18. Free electric power required for execution of work will be made available at one point in the premises. The contractor will have to make his own arrangement for carrying the same to the place of work at his own cost will providing necessary cable, wiring etc. with proper safe guard / caution boards prominently displayed for the safety of Ministry staff and others.
19. If rates quoted by the contractor are found inconsistent and overall quotation is abnormally low or for any specific item(s), the Ministry reserves the right to reject such tender.
20. Quantities given in schedule of quantities are liable to vary and the Ministry will not be responsible for any loss to the contractor due to such variations.
