- (vi) The bids shall be opened on same day at 1530 Hrs. in the presence of authorized representatives of bidders.
- (vii) Late/delayed tenders due to any reason, whatsoever will not be accepted/ considered, at all, under any circumstances.

### 5. Performance Security:

- (i) The successful bidder shall be required to deposit an amount of Rs. 5000/- (Rupees Five Thousand only) within 15 days of issue of letter of intent, as Performance Security.
