**TERMS & CONDITIONS:**

**1. Scope of work:** Removal of old lights electrical works at 4<sup>th</sup> Floor, Pt. Deendayal 'AntyodayaBhawan', CGO Complex. New Delhi.

**2. Eligibility conditions:** Firm should submit copies of VAT registration, PANCard, TIN No., Bank details along with their tender.

**3. Earnest Money Deposit (EMD) :** The bidders shall furnish an amount of Earnest Money of Rs.2,000 (Rupees Two Thousand only) by way of Demand Draft/Bank Guarantee drawn in favour of "DDO, Ministry of Drinking Water and Sanitation" payable at New Delhi. The bid security of the unsuccessful bidder will be discharged/returned subsequent to the award of Contract. No interest for the period will be paid.

**4. Submission of Tenders:**

(i) The quotation indicating rate for entire work to be given (including all expenses likedismantling of old lights/structures, labour charge etc.)

(ii) The rates should be mentioned in figures as well as in words exclusive of taxes.

(iii) The quotation along with an envelope containing EMD is to be kept in a big sealed envelope.

(iv) The sealed envelope containing bids must be delivered to the Under Secretary(Genl.), Ministry of Drinking Water and Sanitation, 8<sup>th</sup> floor, Pt. Deendayal 'AntyodayaBhawan', CGO Complex, Lodhi Road, New Delhi by 14<sup>th</sup> March, 2017 at 1500 Hours.

(v) The bids shall be opened on next day i.e. on 15<sup>th</sup> March, 2017 at 1530 Hrs. in the presence of authorized representatives of bidders.

(vi) Late/delayed tenders due to any reason, whatsoever, will not be accepted/considered, at all, under any circumstances.

**5. Payment:** Payment to the successful bidder shall be released after successful and complete installation of LED light. For payment successful bidder should submit pre-receipted bill (in-triplicate) to enable us make payment in his favor only after complete installation of LED lights.

**7. Validity of Tender:** Rates quoted by the Firm shall remain valid for a period of one year from the date of awarding the contract.
