


Kindly find enclosed a copy of details of location of Border-out Posts in your state where provision of drinking water facility as observed by Assam Rifles is lacking.

3. It is also advised to get in touch with the state level unit of Assam Rifles (Engg. Bn) so that such projects can be formulated based on their requirements. Further, the State authority may also club together schemes meant for various CoBs / BoPs locations in case the BoPs / CoBs of different DGFs are located in reasonably near distances from source of water.

After preparation of DPRs with Techno-Commercial proposal the same may be submitted to this Ministry for further consideration & forwarding to Border Management Dept of Min of Home Affairs (MHA). The funding of such projects would be provided by Ministry of Home Affairs through Ministry of Drinking Water and Sanitation as earmarked funding

3 It is also requested to instruct PHE / RWSS dept in your state to get in touch with the state level unit of SSB (Engg B) so that such projects can be formulated based on their requirements

4 Further, the State agency may also club schemes meant for other nearby BoPs of different BGF in case they are located in reasonably near distances from source of water and can be served collectively




