This is in context of news of flood across the country learnt through media.

2. As per IMIS data as on 26.07.17, the State wise availability of NRDWP funds (Programme) is annexed. As per table annexed, 15% amount of balance funds may be utilised against O&M to meet emergent requirements. Besides, 25% funds of total NRDWP funds can be used as flexi funds by complying with the guidelines/directions contained in Ministry of Finance OM No. 55(5)/PF.II/2011 dated 06.09.2016 to meet the requirements in this regard.

3. The following measures may be taken up on "urgent" basis for providing safe drinking water in the affected rural areas for the following purposes.

- a) Raising tube-wells, hand-pumps and platforms above flood water level to prevent contamination.
- b) Accurate maps showing update water supply systems facilities should be maintained at all times.
- c) Essential stockpiling of supplies like water purification tablets, essential spare parts including detailed user and safety instructions (IEC) in local language etc. must be ready in a warehouse.
- d) Identifying and maintaining lists of mobile water purification installations available for supplying clean drinking water.
- e) Ensuring water supply systems and traditional water sources are maintained and kept functional.
- f) Water Quality assurance:- Ensuring water quality and regular chlorination of drinking water sources (both at source & point of collection) should be taken up on priority with suitable water quality monitoring system in place.
- g) All technicians must be trained on repair and restoration of water sources in emergencies.

For Sanitation purpose which has impact on drinking water quality, the following measures may also be taken:-

- a) For areas prone to floods, appropriate approaches to sanitation such as raised latrines, pit liners or rings, sealed pits / Eco-san toilets must be constructed.

b) Safe management of sanitation waste to prevent outbreak of disease & maintaining a clean environment / identifying and maintaining lists of mobile toilets units.

5. In addition to the above, you may like to depute JEs / SEMs from non-affected areas to affected areas to help in immediate repair and restoration works. Please create a toll-free number in the CE Office urgently and inform the number to all DCs, SEs, EEs and BDOs urgently. This facility should be working on 24x7 basis and direct the CE/E-in-C to report the situation over mobile to this Ministry till situation improves.

6. All possible measures may please be taken to provide potable drinking water and sanitation to the affected rural population.
