Subject: Restructuring of the Nirmal Bharat Abhiyan and its replacement by “Swachh Bharat Mission (Gramin)”

Sir/Madam,

In continuation of D.O. letter of even no. dated 30th September, 2014 from Secretary, Ministry of Drinking Water and Sanitation on the subject mentioned above, the following is intimated:

- a) With effect from October 2, 2014 the Nirmal Bharat Abhiyan has been restructured as Swachh Bharat mission (Gramin). The Programme shall, therefore, be called Swachh Bharat Mission (Gramin) (SBM-G) from October 2, 2014 onwards.
- b) The new provisions of the Swachh Bharat Mission (Gramin) has been communicated in the letter on 30th September, 2014 and will be applicable to all cases where Administrative Sanctions are issued on or after October 2, 2014. The enhanced incentives of Rs.12,000/- (Twelve thousand only) for IHHLs will have water for hand washing and toilet cleaning facilities. In respect of the sanctions issued prior to October 2, 2014 the pre-revised incentive rate shall prevail. No fixed amount has been kept for beneficiary contribution. However, it is suggested that beneficiary contribution should be encouraged so that there is “ownership” of IHHL.
