Subject: Annual Implementation Plan (AIP) 2015-16 under the Swachh Bharat Mission (Gramin)

Dear Sir/Madam

The Annual Implementation Plan (AIP) under the Swachh Bharat Mission (Gramin) is required to be prepared by all States for 2015-16 to assess and finalise the activities to be undertaken by the States in accordance with the programme guidelines.

The main objective of the Annual Implementation Plan (AIP) is to provide a definite direction to implementation of the programme in the State in consonance with national priorities and goals, and also to ensure monthly and quarterly monitoring of physical and financial progress during the course of the financial year vis-à-vis the planned activities included in it and the objectives of SBM(G).

(I) Important points

Some important points regarding the implementation of the SBM(G) are highlighted:

- (i) Adequate staffing at appropriate levels of seniority, as suggested in the SBM(G) guidelines, have to be ensured at the State, District and Block levels by every State, if the goals of the SBM(G) is to be achieved. These persons have to be adequately oriented about the programme. States are urged to ensure setting of the adequate implementation structure, as the availability of funds may be linked to this.
- (ii)IEC has been one of the weaker components under the SBM(G). The MDWS has initiated a large media campaign on both Government and Private TV as well as radio channels. Now that the SHACS has been launched, States are to prepare State and District level IEC plans on the basis of the SHACS and include and implement the same as part of the AIP. Assistance is available to the states to prepare these Plans.
- (iii) SLWM activities have been given special emphasis in the SBM(G), and may be takenup in all GPs irrespective of whether they are NGP or not. MDWS is providing assistance to States to formulate a State-wise SLWM Policy, by releasing a framework from that has been already circulated. States have to ensure that SLWM projects are initiated in all GPs in the shortest possible time.

- (iv) The role of Partner agencies and Support Organisations to assist in the sanitation programme is important. Government does not have the required manpower to reach every HH in every GP. Thus States have to involve reputed and experienced NGOs/CSOs/Institutions/Agencies who can assist in handholding the GPs as they move towards a clean environment and ODF status.
- (v) MDWS has in December 2013 issued guidelines for utilizing CSR in Rural Sanitation. States should monitor the CSR interventions in the State, give necessary assistance, and ensure the reporting of the progress in the SBM (G) MIS.
- (vi) As per XIIth Five Year Plan document, Community Sanitary Complexes are to be provided water using funds under NRDWP. Sanitation and water supply departments in States must take proactive measures on this and ensure the supply of water to these institutions and especially to toilets constructed in these buildings.

(II) Annual Implementation Plan for 2015-16

- 1. For the year 2015-16 it has been decided that presentations and discussions at official level with the Ministry of Drinking Water and Sanitation, Government of India in New Delhi will be held in January/February/March 2015.
- 2. As per directives of the Planning Commission, the Ministry is required to make expenditure in respect of SCs and STs in proportion of 22% and 10% respectively. Although the NBA programme is being run in demand driven mode as per the actual demand generated, however, while preparing the AIP, it is desired that expected expenditure on these categories may be suitably indicated so that necessary information may be compiled accordingly to fulfil the guidelines of the Planning Commission.
- 3. For AIP preparation purposes, the eligibility of the State for the Grant in Aid under SBM (G), anticipated opening balance as on 01.04.2015 and achievable physical objectives in the financial year may be taken into consideration. The final physical objectives will be subject to availability of funds.
- 4. Further, while proposing the Annual Implementation Plan, the following may be considered:

(a) IEC Plans

Detailed planning and execution of IEC activities in a focused manner is essential as per the state IEC Strategy/Plan and District level IEC Plans, which states have to prepare based on SHACS. A detailed plan therefore needs to be presented on the basis of the Plans developed at state and district levels for intensive IPC activities for behaviour change and generation of effective demand for sanitation facilities taking into consideration the funds available under the Head as per the approved project outlay.

(b) IHHLs

The objectives identified for completion of coverage of IHHLs in respect of both APL and BPL households which has to be prioritized based on the convergence issues identified so as to have maximum Open Defection Free (ODF) communities. The aim should be to saturate maximum GPs through effective demand generation.

(c) Community Sanitary Complexes

The objectives identified for completion of Community Sanitary Complexes should be taken up only after specific commitment from the community to own up the responsibility of their operation and maintenance. Further arrangements for Water supply and power supply needs to ensured before CSCs are built.

(d) Solid and Liquid Waste Management

NBA till now has concentrated more on individual household sanitation facilities. One of the important objectives of SBM(G), however, is to improve the general quality of life in rural areas which is not possible if the general cleanliness of the Gram Panchayat (GP) is not maintained apart from ODF status. Effective SLWM is also one of the eligibility criteria for NGP.

Projects need to be proposed therefore under Solid Liquid Waste Management component of SBM(G) in all GPs without any exception.

Further Menstrual Hygiene Management (MHM) has recently been included in the SLWM activities. Specific Plans have to be made to implement this activity within the SLWM component.

(e) Convergence

As part of the approach in the 12th Five Year Plan recommended by the Working Group, better convergence between NRDWP and SBM(G) is envisaged so as to have a saturation approach for sustained water supply and sanitation systems. Accordingly, a conjoint planning and implementation process for both the schemes is to be ensured.

(f) Support activities at State level

Detailed State and District level IEC plans have to be prepared on the basis of SHACS, focusing on IPC. HRD/Capacity building plans on the basis of TNAs and funds needed for State and District level activities needs to be specified.

(g) CSR Activities

The MoDWS has issued CSR Guidelines with regard to Sanitation in the States. The effective utilisation of CSR funding in sanitation has to be promoted at the State and District levels.

(III) AIP Meeting

A template for furnishing the details of AIP 2015-16 is enclosed. State Annual Implementation Plan (AIP) as per the template may please be sent in hard copy and also uploaded on Ministry Website/SBM(G)-MIS by 2 days before meeting date.

The presentations and discussions at the official level with the Ministry will be held in New Delhi in January/February/March 2015. Schedule is attached.

You are requested to be present for the PAC meeting on the AIP for SBM(G) for your state-along with the State-SBM(G) Coordinator, State IEC and HRD Consultants and SLWM Officer In-charge on the scheduled date and time mentioned against your State in the attached schedule. The meetings will be chaired by Joint Secretary(Sanitation) in the Conference Room of Ministry of Drinking Water and Sanitation, 4th Floor Paryawaran Bhawan, CGO Complex Lodhi Road New Delhi.

Introductory Note

The main objective of the Annual Implementation Plan (AIP) is to provide a definite direction to the programme for creation of Swachh Grams. It is also required to provide basis for monthly and quarterly monitoring of physical and financial progress during the course of the financial year visà-vis the planned activities.

Achievements against the AIPs shall be the basis to Incentivise States who perform well. Performances against the AIPs shall be evaluated and performances of States published on the MDWS website. A dashboard that ranks States periodically on a range of performance indicators would be prepared and shared with States.

The Annual Implementation Plan 2015-16 should include the following:

- a) A Perspective Plan, with yearwise breakup, indicating how the States plan to achieve SBM (G) goals by 2019
- b) report on the progress made by the State in achieving the objectives of SBM(G) during the previous year against the AIP objectives;
- c) reasons and comments for variation, if any;
- d) a detailed plan of the IEC, triggering and capacity building activities proposed to be taken up in the ensuing financial year;
- e) a plan of activities with physical and financial estimates under each component of the SBM(G) for the proposed financial year with agreed time lines. A summary of district level Plans is to be provided;
- f) Monthly Quarterly projected targets, so as to be able to monitor progress;
- g) Plans to ensure sustainability of the interventions made;
- h) Details of plans for monitoring and evaluation to be carried out at the state level;
- i) Write ups of success stories, best practices, innovations introduced, new technologies used etc.

Methodology:

- The AIPs for the District should be prepared by consulting the plans of the Gram Panchayats. These GP plans should be consolidated into Block Implementation Plans and further into the District Implementation Plan. The State Mission Authority will suitably consolidate the District Implementation Plans as the State Implementation Plan.
- Special focus is to be given for the IEC Plan of the state. Comprehensive planning has to be done for taking up SLWM in the State.
