**Subject:** Clarification Regarding the Requirement of Documents for the release of Funds under NRDWP

This is in continuation to this office letter dated 12.11.2010 on the above subject. The following clarification is being issued with respect to the requirement of documents for the release of Funds under NRDWP Programme Fund and Support Fund.

#### 1. NRDWP Regular Funds/Programme Funds.

As mentioned in Para A(v) of the letter dated 12.11.2010, 'Audited Statement of Accounts of the SWSM i.e. Receipt and Payment account for 2009-2010, Income & Expenditure Account for the same period and Balance Sheet as on 31.3.2010 by a Chartered Accountant, empanelled by the CAG, needs to be furnished.

It is reiterated that for the year 2009-10, ASA from AG is not required. However the audit report of the SWSM by the Chartered Accountant who shall have to audit all receipts and expenses of 2009-10, needs to be furnished. In this regard an indicative Proforma of the audit report is enclosed.

#### 2. Support Funds

With reference to Para B (i) of the letter, it is clarified that in respect of fund released separately for various Support activities for the period up to 2008-09, if the ASA by the AG does not reflect activity wise breakup, then the State Department have to provide the activity wise breakup of expenditure in the UC. However, the figures in the UC and ASA for Opening

Balance, Grants, Utilisation and Closing Balance should match with each other. UC and ASA need to be provided for each financial year separately.

- 3. Proposals need to be submitted separately for the release of NRDWP Programme Funds and Support Funds.
- 4. All the requirements mentioned in the letter dated 12.11.2010 (copy enclosed) need to be complied with at the time of submission of proposals for release of the second installment.
