This is to intimate that fund under NBA have been released to 17 States under NBA in the month of December, 2013 (3rd quarter of current financial year 2013-14) details are at annexure - I. Sanction orders have been uploaded in format No. C6 in NBA MIS.

As you are aware that till now, SWSM released the funds to the districts as per the Sanction Orders issued by the Ministry of Drinking Water and Sanitation. However, from now the State Government will be responsible for allocation of funds to Districts. The funds released to State Water and Sanitation Mission will be allocated to Districts as per requirement of Districts and provisions of PIP.
