- ii. Area Officers will assess respective States /UTs Quarterly progress in implementation of the programme.

- iii. Area Officers will look into the pending Utilization Certificates and Audited Statement of accounts as per the provision.
- iv. In implementing the programme, IMIS is one of the key component and Districts are required to enter data in IMIS. Area Officers will check the entries in IMIS regularly and in case of any delay, they will take up the matter with the States/UTs /Districts immediately.
- v. After the visit to States/UTs, Area Officer (s) will submit report and debrief Joint Secretary (Sanitation) /Director (NBA) and will follow up the points noted during the visit. They will also brief Secretary, DWS.
- vi. Area Officers will peruse VIR cases and Complaint cases with reference to their allocated States.
