- iii.) To process the Annual Action Plan of the State/ UT in the prescribed formats, follow up and assist in finalization of the same by the State/ UT as per recorded plan discussion minutes;
- iv.) To monitor the progress of implementation of rural water supply and sanitation programme as per final AAP and other activities under AAP;
- v.) To undertake visits to NGP villages from time to time;
- vi.) To visit States as member of Inter-Ministerial Central Team in the event of Natural Calamity for on the spot assessment of drinking water and sanitation situation in the State concerned;
- vii) To maintain up to date status notes and information on issues relating to rural drinking water supply and sanitation of the allocated States;
- viii.) To provide information for framing suitable replies to VIRs, Parliament Questions, matters raised under Rule 377, Special mentions raised in Lok Sabha/ Rajya Sabha, etc. in respect of State concerned;
- ix.) To provide technical and policy guidance to the State Government; and
- x.) Any other work assigned by Joint Secretary(DWS)/ Secretary (DW&S).
