Sub - Assessment Study of Impact and Sustainability of NGP

Dear Sir/s,

The Department of Drinking Water Supply is undertaking the above mentioned study on the NGP awarded GPs during 2005-2008. The main purpose of the study is to assess the impact of NGP on the pace of progress of sanitation availability and usage in the country under TSC and its related impacts on health, education, gender empowerment, social inclusion in rural areas on different user groups particularly the rural poor. This study will also assess the durability and sustainability of the provision and usage of sanitary facilities over time. The rationale of this evaluation study will be to provide important evidence on the NGP component of the TSC. The study will provide a national level report on assessment of impact of NGP.

A sampling methodology has been framed in consultation with the Adviser (Stat) of MoRD and UNICEF. In the proposed study 12 States will be surveyed by the agency selected by the DDWS. A sampling procedure is also mentioned below –
