
Sir,

2. For the purpose of the study, consultants from Mott MacDonald will **review the reports submitted by the States and also visit State Rural Water Supply Departments** to verify the data/documents/supporting evidences submitted by the State on Management Devolution Index including rural population managing rural drinking water supply schemes.

As the Consultant have a mandate to review the data/documents/supporting evidences thus, it is requested that the State (respective department) should **keep copies of documents mentioned in the Annexure** ready for their review and collection. Documents refer to mostly signed hard copy of Government Orders which need to be verified and collected during the field visits.
4. It is thus requested to extend **necessary support** to the representatives of Mott Macdonald Pvt. Ltd as and when they approach you for seeking specific information and documents for the above mentioned study.
5. States are requested to offer their support the Consultants for carrying out the study in a timely manner. States are also requested to share the information regarding Population Managing Drinking Water Supply Schemes as early as possible (refer this Ministry's letter No. G-11011/3/2011-Water, dated 4th July 2013).

Dear Sir/ Madam,

The fund allocation criteria in the NRDWP guidelines as amended in 2011 provide for 10% weightage to 'Rural Drinking Water Supply Schemes weighted by Management Devolution Index'.

2. The Management Devolution Index (MDI) for the year 2012-13 was calculated on the basis of relevant documents submitted by the States and the scores obtained by States were hosted on the website of the Ministry. Now, the Ministry requires obtaining information on population managing rural drinking water scheme and on other indicators for arriving at MDI for 2013-14 to finalize the Incentive Fund.

3. In this context, you are requested to furnish all relevant updated information in the same formats viz A, B, C, D and formats 1-6 which were circulated in 2012-13 for finalization of incentive fund. A copy of the list of indicators for MDI for rural population managing drinking water supply schemes along with formats A-D and 1-6 is enclosed for your reference. It is also requested to furnish information regarding "Rural population managing rural drinking water supply schemes (population in thousands as per 2011 Census)" in the table given below:
