OFFICE MEMORANDUM

Subject: Regarding earmarking of IEC funds for States / UTs to carry out State Level IEC activities and increase in amount for Start-up Activities – modification in Nirmal Bharat Abhiyan (NBA) Guidelines

Representations have been received from several States demanding earmarking of certain part of IEC funds to be utilized for carrying out State level IEC activities and also for enhancement of amount for start-up activities. The matter has been considered by the Ministry of Drinking Water and Sanitation, Government of India and it has now been decided, with the approval of the Competent Authority, to amend the NBA guidelines (the changes have been underlined and printed in bold) as indicated below:-

Additional fund requirement, if any, shall be met by the State	Para 5.1.1. The Start-up activities include:  a. Conducting of preliminary survey to assess the status of sanitation and hygiene practices  b. Base line survey  c. Orientation of key personnel at the District/GP level  d. Preparation of State Plan.  The cost of Start-up activities will be met from the IEC funds <u>at the rate of upto Rs.8/- per HH with a ceiling of Rs. 20.00 lakh.</u> Additional fund requirement, if any, shall be met by the State.

It is requested that above mentioned modifications in NBA guidelines may be noted and may be brought to the notice of all concerned for necessary action.
