The quotations will be opened in the Room of Under Secretary, 8<sup>th</sup> floor, Paryavaran Bhawan, CGO Complex, Lodhi Road, New Delhi. The bidders or their representatives (not more than one for each quotation) may be present, if they so desire, at the time of opening of quotations.

The sale will be governed by the following conditions:-

- I. The bidders are required to pay Earnest Money of Rs. 5000.00 (Rupees Five Thousand only) for the vehicle
- II. Earnest Money is payable by means of Demand Draft drawn in favour of PAO, Ministry of Drinking Water & Sanitation, New Delhi. (payment by cheque or cash shall not be accepted)
- III. Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
