Subject:-Registration / mapping of NRDWP fund flow in PFMS and
implementation of EAT module for financial payments.

Madam/Sir,

In order to bring in efficiency and transparency in the implementation of NRDWP, rolling out of Public Finance Management System (PFMS) needs to be prioritized. This Ministry's has already sent letters No. W-11011/10/2017-Water-I dated 19.06.2018, 25.06.2018 and 13.07.2018 for registration / mapping of NRDWP fund flow in PFMS and implementation of EAT module.

2. In spite of repeated reminders to States, it has been found that some of the States like Arunachal Pradesh, Haryana and Telangana have not even registered / mapped the State Level Agency (SLA) in the PFMS. State / UTs wise status of registration / mapping of State Level Agency (SLA) is enclosed for perusal.

3. In this connection, State / UTs are requested to carry out the following on priority:


- Mapping must be completed after registration. Un-mapped agencies need to be mapped on priority basis.
- The states that have already registered SLAs and completed the mapping process, now must focus on District, Block & GP Level Agency Registrations and respective mapping process.
- States to provide the list of authorized agencies at all levels.

4. In view of the above, it is requested to complete the process for registration / mapping for State Level Agency (SLA) latest by 15th December, 2018 positively. It is also requested to a weekly status report in this regard is required to be sent to this Ministry. Please treat this as of utmost importance as all future funding/ releases would require. PFMS compliance as per Finance Department's instructions.
