2. Scope of Work:

- a) The empanelled hotel/resort/guest house (hereinafter referred to as "Agency(ies)") have to provide accommodation on single/ Twin sharing basis to the participants/ officers/ officials of SPM-NIWAS in well maintained neat and clean standard accommodation amenity on Modified American Plan (MAP) basis (i.e. booking option that includes the room night, a free breakfast and one major meal) with all complementary services, if any with all requisite facilities in each room, each day to each occupant round the clock as follows:
 - i. 24 hours air conditioning,
 - ii. hot and cold water,
 - iii. power supply, WiFi,
 - functional TV, suitable chair, table/sofa iv.
 - ٧. Electric kettle with tea/ coffee/ sugar/ milk sachets.
 - vi. cleaned & pressed bed sheets/quilts/blanket, bath towels, hand towels,
 - vii. mineral water bottles, 2 ltr. per person per day.
 - viii. Toiletries kit,
 - ix. bathroom slippers etc.
- b) The empanelled agency should have at least 50 functional rooms.
- c) There should be a dining space for accommodating at least 50 guests at a time.
- d) The eligible agencies offering lowest price shall be empanelled category wise based on star rating/ without star and the category wise lowest rate (i.e. on comparing in-between the equivalent star or without star category) shall be applicable for each agency for empanelment with SPM-NIWAS.
- e) The Institute will utilize the services of empanelled agency(ies) on call and rate contract basis as and when required and payment will be made as per the rate contract. The institute reserves the right to empanel more than one Hotel/Resort/Guest house, if required on similar rates as offered by L1 bidder on mutual consent in either case in each category.
- f) Flexibility of check in/out may be considered by the empanelled hotel/resort/guest house subject to exigencies. The guests may be allowed to keep their personal belongings in the hotel during early check-in / late check-out without any extra charges.
- g) SPM-NIWAS will pay the charges pertaining to stay arrangements on MAP basis for each participant for the period of stay officially communicated by the Institute only. Any other expenses for any other facilities availed by the participant (s) from the hostel/resort/guest house beyond the scope of services would be borne by the participants/individuals personally and the same will be collected by the Hotel/ Resort/ Guest house from the concerned personnel/ officer/official. - h) The officers of the Institute shall visit the hotel/resort/guest house to check the establishment /facilities, if deemed necessary or required by the institute and if the environment/ facilities are not found satisfactory, the Institute shall not empanel such hotels or terminate the empanelment with immediate effect.
- i) Billing will be on reimbursement basis on actual check-in/ check-out of the guests on submission of tax invoice and payment will be made by the SPM-NIWAS within 30 days of receipt of the proper tax invoice. No advance payment would be made by the SPM-NIWAS for booking of rooms.
- j) The Hotel accommodation will have a facility to provide first aid and doctor on call facility for medical emergencies.
- k) Booking information will be communicated by the Institute 48 hours in advance. In case the booking is cancelled by the Institute before 08 hours of the check-in, the empaneled hotel/resort/guest house shall not charge any cancellation fee for the booking.
- The hotel/ resort /guest house should be located near to SPM-NIWAS preferably within a radius of 20 kms by road.
- m) A nodal officer from the hotel/ resort/ guest house must be deputed for the coordination purpose with SPM-NIWAS, Kolkata.
- n) The Director, SPM-NIWAS reserves the right to terminate the empanelment of any agency without assigning any reasons, in case of failure to provide the services or if the services are not found satisfactory by the Institute based on feedback of the staying participants/ trainees/ officers/ officials.

3. Eligibility Criteria:

- a) The bidder/ agency should be a legal entity company/partnership firm /LLP/proprietorship firm duly registered under the suitable act of State/ Union, as applicable (attach valid certificate).
