**Sub. :** Implementation of E-procurement system in Rural Water Supply sector.

Please refer to this Ministry's letter of even number dated 27.02.2014 and 09.06.2014 on the above mentioned subject. It was stated that the above mentioned States should fully implement the e-procurement system for works/procurement under NRDWP.

2. The Ministry of Drinking Water and Sanitation has provided funds to NICSI, New Delhi in two installments for implementation support of GePNIC (Government e-procurement) for 16 States vide sanction orders dated 28.02.2012 and 27.11.2013. This is for fully implementation of the e-procurement system in the States. On the examination of the data available on the e-procurement Software/Portal, it has been found that most of the target States are not fully utilizing or utilizing minimally the e-procurement system and the progress of these States are unsatisfactory.

3. It is requested to furnish the clarifications/ action which are mentioned as under:-

a) Whether the States have got the Services of manpower. Nos. / types of manpower and for what period have been provided. The required status may be provided at the earliest as the table below :-


