
Subject: Invitation of bid for Purchase of surplus/unserviceable/obsolete store in the Ministry of Drinking Water & Sanitation.

The tender should reach the undersigned by **28th October, 2014** upto 3:00pm.

- 1) Terms of delivery: full payment plus applicable taxes is required to be made by the successful tenderer, before stores are lifted.
- 2) Bids will be opened on the same day 4.00 PM in the presence of the tenderers who may wish to participate. Venue of tender opening will be room of Under Secretary (Admn.) of Ministry at 8th Floor, Paryavaran Bhavan.
- 3) Prices quoted should be on firm and final basis. The Ministry reserves the right to cancel the tender process if the quotations by all the bidders are unreasonably low.
- 4) Quotations by Telex, Cable or FAX will be rejected summarily.
- 5) The surplus stores are located at 9th Floor, Paryavaran Bhavan (toilet) & 6th Floor, Block No.11, CGO Complex Lodhi Road, New Delhi. The same can be seen by the prospective tenderers if they so desire with prior appointment with Under Secretary (Admn.) on any working day between 2.00 Pm to 4.00 PM.
- 6) EMD of Rs.10,000/- (Rupees Ten Thousands only) is required to be furnished along with the tender. Demand Draft should be drawn in favour of DDO, Ministry of Drinking Water & Sanitation, New Delhi.
- 7) The successful tenderers will have to lift the complete goods immediately within 48 hours after making full payment of the bid value of store.
