2. As you are aware, Department has accorded highest priority to the capacity building of different stakeholders to achieve the goal of universal access to safe drinking water in rural areas. The meeting will be chaired by the Secretary, Department of Drinking Water Supply, Government of India.

- ii.) attend the aforesaid meeting as per schedule, make a presentation on your plan of action (2010-11) and also bring hard copy (8 sets) of the same for distribution in the meeting, and
