## A) Details of the requirements

- One hundred and forty-two (142Nos.) Green Plants and fifteen (15) flower pots are required to be placed in the corridors of Krishi Bhawan, Nirman Bhawan, 8<sup>th</sup>,9<sup>th</sup>, 12<sup>th</sup> floor, Paryavaran Bhavan, 6<sup>th</sup> floor Block No.11 and in the rooms of Minister, Secretary and Joint Secretaries resppectively. These plants are to be changed twice in a month. Exact quantity of cut flowers to be supplied will be decided at the time of award of contract.
- The number of Green Plants and cut flowers may increase/decrease during the contract period and the payment will be made proportionately.
- Quality of Cut Flowers and Green Plants will be according to the satisfaction Ministry of Drinking Water and Sanitation.

## B). Terms and Conditions:-

- 1. The contract will be valid for a period of one year from the date of award.
- The firm/ contractor should have prior experience in similar field and should have undertaken identical work in any Government Department/PSUs/Autonimous bodies/Research Institutions etc. for at least two years.
- 3. The payment against supply of above items will be made on monthly basis for which bills may be submitted as per approved rates by the 1<sup>st</sup> week of each month, in respect of jobs executed during the previous month with certificate, from officers nominated by this Ministry for this purpose, about quality of cut flowers and green plantsprovided and also about change of Green Plants twice in preceding month.
- In the event of any loss incurred by this Ministry on account of the negligence of Agency/firm/contractor, the later shall compensate the loss either by replacement or by payment of adequate compensation.
- 5. The Agency shall be responsible for the conduct and behavior of its employee.
- The Agency shall not appoint any sub-contractor to carry out any obligation under the contract.
- The Agency/firm/contractor shall also not appoint any close relative of any employee of this Ministry for carrying out the work in any manner whatsoever.
- The order placed by this Ministry shall be carried out strictly as per terms and conditions of contract and any delay/non delivery or deviation from written agreement may attract monetary penalty of Rs. 500/- for each day of non-compliance.
- 9. If there is repeated deviation from scheduled delivery the contract may be terminated.

10. The work relating to replacement of plants/cut flowers in flower pots shall be completed by 8.00 a.m. each day.

11. The quality and freshness of Cut Flowers supplied shall be ensured and maintained by

the Agency/firm/contractor.

12. The plants supplied in this Ministry as well as the pots shall be regularly maintained/watered and shall be replaced two times in a month.

13. In case any plant or Cut Flower pot is found in unsatisfactory condition, the same will have to be replaced by firm immediately on direction of this Ministry.

14. The monthly payment shall be released by this Ministry on the basis of satisfactory services by the firm.

15. The matter regarding renewal of contract beyond the initial period of contract of one year shall be at the sole discretion of this Ministry.

16. The persons deputed by the firm for placing the Cut Flowers in the Chambers of Hon'ble MOS/Senior officers shold not be changed without prior knowledge and consent of this Ministry.

17. The earnest money shall be forfeited if the contractor declared successful resiles from

the offer or does not accept the work for any reasons, whatsoever.

18. The successful bidder shall furnish a performance security of an amount of Rs. 30000/-in the form of an account of payee demand draft drawn in favour of the "PAO, Ministry of Drinking Water and Sanitation, New Delhi, payable in New Delhi.
