MINUTES OF THE MEETING HELD TO DISCUSS ANNUAL IMPLEMENTATION PLAN 2014-2015 UNDER NBA FOR STATE OF KARNATAKA

- 1.1 A meeting to discuss Annual Implementation Plan 2014-2015 of State of Karnataka was held at 10.30 PM on 24th March, 2014 at Conference Room of Ministry of Drinking Water and Sanitation, 12th Floor Paryawaran Bhawan. CGO Complex, New Delhi. The meeting was chaired by Shri Saraswati Prasad, Joint Secretary (Sanitation), Ministry of Drinking Water and Sanitation, Gol. The list of the participants is annexed.
- 1.2 At the outset. Shri Sujoy Mojumdar, Director (NBA) pointed out achievement in construction of IHHLs is only 60% against 2013-14 targets. State Secretary informed that about 5.16 lakh IHHLs will constructed by March, 2014 against AIP-2014-15 targets. Almost all schools already have toilets. Director (NBA) pointed out that all Sanitary Complexes. School toilets and Arganwadi toilets targeted for 2014-15 should be provided with water supply from NRDWP funds. Handwashing facilities in Schools should also be provided funds from NRDWP. Instruction on both of these issues have been issued by NRDWP Division. As per IAY website, no toilet has been provided in IAY households during 2012-13 and 2013-14. Director(NBA) said that all IAY houses should invariably be provided toilets under NBA. He also suggested that CSR funds may be leveraged for maintenance of Schools, Anganwadis toilets and Sanitary Complexes. State has requested to increase the slabs for Solid and Liquid Waste Management. Shri Sujoy Mojumdar(NBA) suggested that professional/technical experts should be engaged for preparation of Solid and Liquid Waste Management Projects. Director(NBA) said that looking at looking the anticipated achievement in 2013-14, the State can consider increasing the targets under IHHLs for 2014-15. Funds will be available if required. State is focusing on IEC activities in which IEC Consultants at block level have been engaged.
- 1.3 Physical Progress: As against cumulative objectives of 2889224 for individual household latrines (IHHL) for BPL, 2981691 IHHL for APLs. 1305 Sanitary Complexes. 39267 for school toilets and 26353 for Anganwadi toilets, the State has achieved 2423687 for individual household latrines (IHHL) for BPL, 2320163 IHHL for APL, 1016 Sanitary Complexes, 44172 for school toilets and 29308 for Anganwadi toilet. Thus balance targets do exist against original PIP, for IHHLs and CSCs.

During 2013-14, against annual objectives of 304927 for individual household latrines (IHHL) for BPL, 182360 IHHL for APLs, 533 Sanitary Complexes, 2453 for school toilets and 3495 for Anganwadi toilet, the State has achieved 223893 for individual household latrines (IHHL) for BPL, 84041 IHHL for APL, 40 Sanitary Complexes, 455 for school toilets and 514 for Anganwadi toilets upto February, 2014.

- 1.4 Financial Progress: The State has an opening balance of Rs 163.36 crore as of 1st April, 2013. Fund released in 2013-14 is Rs. 65.94 Crore. The expenditure reported of Rs. 85.94 Crore is low as against the funds available in the year 2013-14.
- 2. State has proposed following objectives under Annual Implementation Plan (AIP) for 2014-2015 as per the modified provisions of NBA:

- 3. Financial Objectives for 2014-15: State has projected total requirement of Rs. 49136.40 Lakh from Central share.
- 4. The above objectives as proposed by Karnataka were noted down for consideration subject to approval of PIP to be approved by NSSC in due course.
- 5. State was also appraised of position of toilet construction in IAY houses in the state. Against 109923 no. of houses constructed under IAY during 2012-13, toilets have been provided only for 0 no. of houses. During 2013-14, no toilet has been constructed in the 75246 nos of IAY houses. Thus coordination between NBA and IAY wing has to be established.
- 6. Further, State has done survey in 99.98 % Gram Panchayats for Identification of Insanitary latrines. 3381 Insanitary Latrines found the survey and all 3381 Insanitary latrines have been converted into Sanitary latrines till date.
- 7. State was requested to add IAY toilets in the annual objectives 2014-15. As per discussion held, State was further requested to revise some of the objectives specifically that of SLWM based on financial allocation of funds made by the Central Govt, during 2014-15 & Opening Balances as on 1st April, 2014 and upload the same in the website through online monitoring system. Hard copy of the revised AIP for 2014-15 signed by a senior officer should be sent by 30th April, 2014. District-wise AIP objectives for 2014-15 along with identified GPs should be entered on online Monitoring System. It was informed that the recommendation of PAC for 2014-15 shall be valid for this financial year only.
- 8. Tentative Allocation for 2014-15: Tentative Allocation for 2014-15 shall be finalized after progress report of all the Districts as on 31st March, 2014. However the actual releases during the year 2014-2015 would be subject to:
 - Approved demand of the State.
 - Availability of funds in the budget.
 - The submission of necessary documents that is UC/ASA and certificate by the State Secretary that the Districts to which funds are proposed to be released have compiled with the conditions of release and Audit reports, Utilization Certificates and Progress Reports have been received and scrutinized.
 - The State bringing down its unspent balance to reasonable levels.
 - The fund released in the first installment shall be 50% of the amount approved in the PAC and shall be reduced by the amount of opening balance in excess of 10% of the previous year's release to the State.
- 9. State was requested to accelerate the progress against all component of NBA so that to meet the physical as well as financial objectives projected by state.

- 10. ACTION POINTS: The following Action Points may be noted:-
- (a) State NBA department has to coordinate with IAY department for effective planning and reporting.
- (b) It is clarified that as per MoDWS instruction 50% of funds needed to build toilets in IAY can be given as advance from NBA deptt to IAY deptt.
- (c) State is advised to study the Tamilnadu Model of Integrated Women/Men Sanitary Complexes, for suitability.
- (d) Provision of Water supply and arrangement for O & M in the CSCs and School and Anganwadi toilets may be ensured.
- (e) Regarding MHM, while the MoDWS is in the process of preparing advisories. State may also submit any material which it may have developed including Model, design & costs.
- (f) MoDWS may be kept informed of the experience of carrying out Social Audit in the State.
- (g) State has prepared detailed IEC plans to be supervised by IEC Consultants at the Block level. It is suggested that focus should be on IPC to obtain the best results.
- (h) For the implementation of the NBA, it is suggested that the services of ASHA as well as the Pulse Polio Network may be leveraged.
- (i) MoDWS may be kept informed of the results of efforts to engage All India Institute of Local Self Government in preparation/implementation of SLWM projects.
