Agenda Notes

Annual Action Plan for 2010-11 to be entered in IMIS latest by 31 May 2010. States should also upload the Annual Action Plan for NRDWP-Support Activities

1. Entry of schemes/ water supply points in all habitations should be completed by June 2010.
2. Data of areas affected by left wing extremism (lwe) is being filled by districts in the Planning Commission website hosted at <http://pcserver.nic.in/lwe> under REPORTS section (report as on 31/3/2010 is enclosed). This data does not match with IMIS data. States should ensure that data is completely updated in IMIS so that the same can be ported to the Planning Commission website automatically, to avoid any data discrepancy from 2010-11 onwards.
3. Data Updation should be regular. Generally it is observed that data updation takes place only before a review meeting or VC is called.
4. Last date for Financial MPR updation is 17th of following month. This date needs to be advanced to 15th, due to reporting requirements (to PMO, Cab Sec. & Planning Commission) of DDWS. A view may be taken, in this regard.
5. Annual Data Updation and its importance
6. It has been found that many habitations in which schemes completed during 2005-06 up to 2008-09 have been entered, and yet these were marked as Quality affected as on 01/04/09. States are requested to correct the scheme entries or remove the contamination from these habitations. This has been facilitated through the Annual Data Updation form.
7. Laboratory test results not being uploaded. Several habitations have been marked as quality affected habitations but the supplementary data of lab testing has not been uploaded. This may be rectified.
8. There are many PWS schemes in which Estimated Cost of scheme is above Rs. 10,00,000/- but the habitations covered by the scheme are shown as only one habitation. Such cases may be corrected.
9. Duplicate schemes should be deleted immediately.
10. There are a sizeable number of schemes which have been taken up under NRDWP-Quality or ARWSP-Submission, under which all the covered habitations have been marked as quality affected. This may be clarified / corrected.
11. New Financial MPR

Discussion on GIS

1. Chhattisgarh, Gujarat and Tamil Nadu to demonstrate GIS initiatives in their states.
2. Requirements of a standard GIS platform to be adopted by all states
3. Data Collection formats for Water Sources Information System to be finalized.
4. Requirements of application software to be deployed in hand held devices for collection and uploading of water sources data into IMIS.
