**MINUTES OF THE 47TH NSSC MEETING HELD
ON 27TH NOVEMBER, 2013**

The 47th National Scheme Sanctioning Committee (NSSC) meeting was held in the conference room of Secretary, Ministry of Drinking Water and Sanitation, Nirman Bhawan, New Delhi under the chairpersonship of Shri Pankaj Jain, Secretary, Ministry of Drinking Water and Sanitation, Government of India on 27th November, 2013. The list of participants is given at **Annexure I**.

2. The committee was intimated that the minutes of the 46th NSSC meeting held on 2nd July, 2013 were earlier circulated vide letter no. W-11013/01/2011-CRSP, dated 18.09.2013. No comments however, were received from anyone in this regard. The Committee, therefore, confirmed the Minutes.

3. It was intimated that in the revised project proposals, States were asked to include Base Line Survey Report and latest Census data available in respect of the Districts in support of revision of the project proposal. Any deviations from the Census data were also requested to be explicitly explained in the project proposal.

4. The following proposals for revised PIPs were placed before the NSSC for consideration :-

Proposals considered once earlier by the NSSC in the meeting dated 2 nd July, 2013	Himachal Pradesh, Haryana, Meghalaya, Tripura, Sikkim, Kerala, Maharashtra, Punjab and Madhya
New Proposals	Manipur, Rajasthan, Arunachal Pradesh, Assam, Karnataka, Goa and Chhattisgarh

5. While analyzing the proposals of the 16 States, it was found that in many states the %increase in IHHLs in the revised PIP target over old PIP is higher than the % increase considering decadal growth rate of households as per Census. Therefore, the members of the NSSC decided to constitute a Committee to propose the principles and mechanism to finalize the revised Project Implementation Plan(PIP) targets under Nirmal Bharat Abhiyan with reference to the Census 2011 data and the subsequent Base Line Surveys carried out by the States in 2012-13. Committee will consider the data submitted by the State Governments, data available in Ministry's IMIS as well as data from Census2011 and any other data including data of Census 2001 etc. The Committee will submit their report within 3 weeks of issue of O.M.

There being no other point, the meeting ended with thanks to the chair.
