**OFFICE MEMORANDUM**

**Subject:** Modification in Nirmal Bharat Abhiya (NBA) Guidelines including one representative from MODW&S in the State Scheme Sanctioning Committee (SSSC).


The Nirmal Bharat Abhiyan (NBA) Guidelines are hereby modified, so as to include one representative from MODW&S in the State Scheme Sanctioning Committee (SSSC). Paragraph 7.2.3 of Nirmal Bharat Abhiyan (NBA) has been amended as described below:

1	Para 7.2.3 SWSM shall supervise implementation of NBA in the project districts in the State, ensure convergence mechanism between line departments, prepare the Annual Implementation Plan for each district as per the progress made by districts, receive Grant-in-aid from Centre earmarked for specific project districts and disburse to the DWSMs. SWSM will ensure the convergence of NBA and IAY by including target of toilets in IAY houses in AIP of the districts. The aggregated IAY targets of the project district shall be reflected in the State AIP. All project shall have to be approved by State Scheme Sanctioning Committee (SSSC). The mission shall meet at least once in six months.	Para 7.2.3 SWSM shall supervise implementation of NBA in the project districts in the State, ensure convergence mechanism between line departments, prepare the Annual Implementation Plan for each district as per the progress made by districts, receive Grant-in-aid from Centre earmarked for specific project districts and disburse to the DWSMs. SWSM will ensure the convergence of NBA and IAY by including target of toilets in IAY houses in AIP of the districts. The aggregated IAY targets of the project district shall be reflected in the State AIP. All projects shall have to be approved by the State Scheme Sanctioning Committee (SSSC). <u>In the SSSC there shall be a representative from Ministry of Drinking Water and Sanitation.</u> The mission shall meet at least once in six months.
