Sub: Modification in the Reporting System in the NBA-MIS

Sir,

- 1. The NBA online monitoring system is being used extensively by the Government of India for monitoring the Physical and Financial performance of the programme in the States as well as the districts. However the experience of the reporting by the States in the last year, has led to the need for some modification in the system so as reflect the responsibilities of Officers at the various levels (Block, District and State); improve the timeliness of reporting as well as improve the accuracy of the reported figures.
- 2. With this in view, certain changes are being made in the reporting system on the online IMIS, both for Physical and Financial MPRs.
- 3. From April 2014 (reported in May 2014) onwards, the Monthly Progress Reports (MPRs) for the NBA in each district, will be generated from Gram Panchayat level entries and their subsequent online approvals at District and State levels. These approvals will be mandatory i.e. District MPR Progress can be viewed online in the reports, only after approvals of the data at both the levels.

Software modifications have been made in the online system appropriately.

4. Further as you are already aware, NBA funds are now being released to the State level, with directions that further allocation and release may be done by the States to the Districts.

From 1.4.2014, the MIS has been modified and the funds released to the States will be entered online by MDWS at the Central level. This will be visible online to the States who will then have to further allocate and release it to the Districts/State agencies for expenditure. i.e Provision has been made to enter funds released to the districts and the other agencies at GP level (if required).

- 5. For both the above modifications the following new modules have been hosted online.
 - (i) Fund Allocation Module Allocation of funds to Districts
 - (ii) Fund Release Module Release of funds by State to District and further by Districts to implementing agency at Block level
 - (iii) Expenditure Reporting at GP level
 - (iv) Physical Progress Reporting at GP level
 - (v) District & State Approval forms
- 6. To familiarize the State NBA-MIS personnel with the changes, a 1 day training programme for States MIS nodal officers (+1 additional staff), i.e. 2 persons per State is being organized in MDWS Meeting Hall, 12th Floor, Paryavaran Bhawan on 24 and 25 April 2014. During the session, detailed discussion on the forms will be held. It is expected that the 2 persons who are exposed to the new MIS arrangement in New Delhi shall return back to their States and hold similar Workdshops/training sessions for all the District MIS personnel in the State, to ensure smooth transition to the new system, such that reporting delays do not crop up.
