Subject: Monthly summary for the month of July, 2020 in respect of Department of Drinking Water and Sanitation.

Shamudayik Shauchalay Abhiyan (SSA)

The Shamudayik Shauchalay Abhiyan (SSA) 2020 saw good progress from States throughout the month. So far over 10,000 Community Sanitary Complexes (CSCs) have been constructed since its launch on 15th June 2020. An advisory was issued to States/UTs on 07.7.2020 to re-emphasize the importance of mobilizing districts and villages to construct and maintain Community Sanitary Complexes (CSCs) during the campaign period (till 15th September 2020). Additionally, an advisory was also issued regarding construction of CSCs in convergence with SBM (G) and MGNREGA.

Declaration of Open Defecation Free (ODF) Plus Village

A webinar was organized on the process of declaration of Open Defecation (ODF) Plus villages on 29.7.2020 at 11.00 A.M from New Delhi. About 500 States/District Officials from 13 States/Uts participated in webinar, during which a detailed presentation was made on process to be followed and things to be checked when declaring a village ODF Plus.

Monitoring of Swachh Bharat Mission (Grameen)

A Video Conference was held with ACS/Principal Secretary/Secretary and Mission Directors in-charge of Rural Sanitation in the States of Andhra Pradesh, Assam, Bihar, Gujarat, Jharkhand, Karnataka, Maharashtra, Odisha, Rajasthan, Telangana, Uttar Pradesh, West Bengal on 15.07.2020 at 3.00 p.m. to review the progress of Left Out from Baseline (LOB), No one left behind (NOLB) toilets construction and Community Sanitary Complexes (CSCs) etc.

A Video Conference was held with Chief Secretary and Principal Secretary in-charge of Rural Sanitation in the State of Jharkhand and all District Collectors on 16.07.2020 at 11 a.m. to review the progress of Left Out from Baseline (LOB), No one left behind (NOLB) toilets construction and Community Sanitary Complexes (CSCs) etc.

JJM and SBM G Review and Visits

Field visits were undertaken to review the progress of the SBM and the JJM on the following dates:

- Karnataka — 6-7 July 2020
- Uttarakhand — 19 July 2020
- Anand, Gujarat — 23-24 July

While in Anand, Secretary, DWS also visited the National Dairy Development Board's individual and community biogas plants which converted animal dung and agriculture waste to biogas and bio-fertilizer.

Video Conference (VC) Meetings by Minister, Jal Shakti with Chief Ministers / LGs of States/ UTs of Himachal Pradesh, Haryana, Assam, Uttar Pradesh, Manipur, Tripura, Jammu & Kashmir, Ladakh, Meghalaya, Kerala were held from 04th - 30th July, 2020 to review the timely implementation of Jal Jeevan Mission and Annual Action Plan (2020-21) to achieve 100% FHTC by 2024 and rural water supply programmes.
