OFFICE ORDER

Swachh Bharat Mission-Grameen (SBM-G) Phase-II, a Centrally Sponsored Scheme, is being implemented in the rural areas of all the States/UTs during 2020-21 to 2024-25 with the focus on sustaining the Open Defecation Free (ODF) status of the villages and to cover all the villages with Solid and Liquid Waste Management, i.e. to transform all the villages from ODF to ODF Plus.

2. As per SBM(G) Phase-II Guidelines (which are available at the websites <https://sbm.gov.in> and <https://jalshakti-ddws.gov.in>), there shall be a National Scheme Sanctioning Committee (NSSC) under the Chairpersonship of Secretary, Department of Drinking Water and Sanitation, to approve or revise the Project Implementation Plan and the Annual Implementation Plans of the States/UTs. Apart from the official members, there shall be two non-official members (experts on rural sanitation) in the NSSC.


3. With the approval of the Competent Authority, it has been decided to appoint the following non-official members of the NSSC of SBM-G:

- (1) Shri K.K. Gupta, Social Worker,
Dungarpar, Rajasthan
- (2) Shri S Damodaran, Founder – Gramalaya,
Tiruchirappalli, Tamil Nadu

4. The tenure of the above non-official members of NSSC will be two years from the date of issuance of this order.

5. The above non-official members will be entitled for TA/DA as per Para 1(ii) of the Minister of Finance (Department of Expenditure) Office Memorandum F. No. 19047/1/2016-E.IV dated 14.09.2017 regarding TA/DA entitlements of persons from various fields nominated as non-official in Committee/Boards/Panels etc., as amended from time to time.

6. This order supersedes the earlier order No.S-11016/1/2015-SBM dated 11.08.2020. Hindi version will follow.
