## Action points emerged from the National review Workshop at Bangalore, 2-4<sup>th</sup> May 2012

- 1. States to ensure that the Support Organisation appointing process is completed within the timeline prescribed i.e.  $30^{th}$  May/ $30^{th}$  June. (Please see timeline at the end of the action points)
- 2. States to ensure that Support Organization for the pilot projects are in place and the teams are deployed.
- 3. States to form Steering Committees at State and district levels for the pilot project. The Steering Committee at State level may be chaired by the Chief Secretary/Additional Chief Secretary/Development Commissioner and include members from Departments related to Drinking Water, Water resources, Agriculture, Rural development, Sanitation, Education, Health and include NGOs dealing with water resource management in rural areas. Similar Committees to be formed at District level chaired by District Collector/CEO, Zilla Panchayat.
- 4. States may appoint retired hydrogeologists/Irrigation or PHED engineers with suitable technical background and interest for supporting the project at the field level (district and block). The cost on this account can be met from Support activities of NRDWP.
- 5. States to send a request to MDWS / WSP for
  - i. scheduling the water budget training,
  - ii. training to Support organizations, and
  - iii. exposure visits for their respective pilot Blocks.

Requests for trainings and exposure visits will be considered only after finalization of the Support organizations, signing of contracts, and issuance of work orders to the Support Organizations, and deployment of the SO team in the field.

- 6. Training of Support organizations will be conducted by WSP at Regional level (combining two to three States per training)
- 7. States to organize Water Budget trainings for villages, supported by WSP, and the exposure visits as per the schedule drawn up by WSP after receiving the training requests from the states.
- 8. The States are to prepare an action Plan / work plan for the Support Organization which shall be presented by them in the next workshop.
- 9. Next national workshop to be held in the first week of August 2012.
- 10. States to revive all VWSCs in the Pilot Blocks.
- 11. States to ensure completion of source inventory along with 100 % quality testing and GPS locations for all the Drinking water sources in the Pilot blocks
