In November, 2017, National Rural Drinking Water Programme (NRDWP) had been restructured to make it competitive, outcome based and result oriented. With this, pattern of release of 2nd instalment has also got changed.

This Ministry intends to release the first instalment of this year as early as possible. However, for making this possible, huge unspent balance as on 01.04.2018 may become a hurdle. As such, expenditure is required to be expedited and also the same is to be reported & approved in IMIS. In addition to this, physical & financial progress of various ongoing schemes under NWQSM and submission of proposals of new schemes for this are also required to be expedited for coverage of Arsenic & Fluoride affected habitations within the time frame committed under its guidelines.

Further there is a need of yearly data updation which includes the speedy process of Geo-tagging, updation of milestone based physical progress, work order date for each ongoing scheme and updation of functionality status of completed schemes in IMIS.

To discuss these issues, meeting with States has been planned as per the attachment which will be taken by the undersigned. It is hereby requested to please attend the meeting along with your Chief Engineer and Director (WSSO) and if possible, make a brief presentation on the issues faced by the State Government.
