Dear Sir/ Madam,

As observed from the data being entered into the online IMIS of the Ministry, some States are not achieving their target of covering water quality affected habitations. One of the possible reasons could be that major piped water supply schemes are being planned and implemented.

2. Before taking up implementation of such large schemes, it is also mandatory to obtain permissions/ clearances from various Departments. This may be delaying the project completion on one hand and also escalating the capital cost on the other hand.

3. In order to avoid such delays, it is suggested the **status of various permissions required and obtained be reviewed by you on a weekly basis**, in case you are not already doing so, you may like to designate an officer from PHED headquarters to compile the information on a weekly basis. A format that you may like to use for review of pending clearances/ permission is annexed.

4. It is also suggested that the status of such permissions be taken up by you in the Co-ordination Committee/ Weekly meetings of Secretaries/ SWSM meetings chaired by the chief Secretary of the State.
