Subject: Technical Committee for examination and use of innovations and technologies in drinking water and sanitation sector – regarding

A Standing Committee for Examination of the best technologies concerning water and sanitation was constituted by the then Ministry of Drinking Water and Sanitation vide its Office Order W-11042/ 12/ 2014/ NRDWP/ Water-II dated 11.9.2014 headed by Dr. R. A. Mashelkar, former Director General, CSIR. The tenure of the aforesaid Committee expired on September 10, 2019.

- 2. Government of India has launched Jal Jeevan Mission which aims at Functional Household Tap Connection to every rural household by the year 2024. To achieve the goal of universal coverage in water supply especially on this scale and with speed, there are huge challenges for which innovative solutions with the use of new technologies would be required. Also, under Swachh Bharat Mission Grameen, on 2nd October country has achieved the goal of 'Open defecation free' which needs to be sustained and address new challenges including solid and liquid waste management for which ODF+ is proposed to be launched.
- 3. Keeping this in view, it has been decided to reconstitute the 'Technical Committee for examination of innovation and technologies in drinking water and sanitation sector'. The tenure of the Committee would be for a period of five years from the date of its constitution.

- 5. Based on specific need, with the approval of Co-Chair and Chair, any official or non-official can be invited as a Special Invitee.
- 6. The Terms of Reference (ToRs) to the Committee are as under.
 - a. Invite innovative technologies in drinking water, sanitation, grey water management and solid waste management sectors through Department of Drinking Water and Sanitation on-line portal.
 - b. Short listing the technologies for techno-economic appraisal.



- c. Getting techno-economic appraisal of technologies done as per the ASSURED matrix framework.
- d. Consideration of appraised technologies for acceptance.
- e. To recommend any non-technological interventions needed for achieving the scale of use of technologies.
- Any other aspect/activities required to be undertaken in respect of appraisal of the technologies.
- 7. The expenses towards travel including airfare and local travel (as per GoI norms as amended from time to time) along with a sitting fee of Rs. 4,000 per sitting to non-official members including non-official Special Invitees will be borne by the Department of Drinking Water & Sanitation, M/o Jal Shakti, as per existing norms.
- 8. This issues with the IFD's concurrence and approval of the Minister, Jal Shakti, Government of India.
