## TERMS AND CONDITIONS

1. The invitation is open to all firms dealing in repair and maintenance of furniture items registered with Sale Tax Authorities.
2. Copies of valid Central /State Sale Tax registration certificate should be submitted with the quotation. PAN of Income Tax should also be quoted.
3. The contract will remain valid for the period from 25-07-2007 to 24-07-2008. However, the Department reserves the right to terminate the contract at any time without assigning any reason therefore.
4. The work is to be carried out in the office premises at Nirman Bhawan /CGO Complex, New Delhi and any other venue as decided by the Department.
5. Only such work as can not be carried out in the office premises will be allowed to be done outside the office premises and no extra charges or transportation charges will be paid for that.
6. It will be the responsibility of the contractor to report to the Section Officer on all working days for collecting orders for repair etc.
7. No advance payment will be made in any case.
8. The quotations which are incomplete, unsigned or without application fee will not be considered.
9. The successful tenderer will be required to furnish "Security Deposit" of Rs. 5000/- (Rupees Five Thousand Only) within 30 days from the date of acceptance of the contract. The security deposit shall be in the form of Demand Draft of any nationalized bank drawn in favour of SO (Cash) Ministry of Rural Development, New Delhi. The security money will be forfeited, if during the period of the contract, the services of contractor are found to be unsatisfactory in any respect or in the event of breach of contract by him.
10. If any confusion/ dispute over any matter arises during the period of contract, the decision of this department will be final and binding upon the contractor.
