Subject: Jal Jeevan Mission – **Virtual Conference of State/ UT Ministers in-charge of water supply** to review the implementation of JJM and 100–Days Campaign – regarding

Madam/ Sir,

The implementation of Jal Jeevan Mission (JJM) – Har Ghar Jal to provide assured potable piped water supply to every rural home, is in full swing. Further, to make provision for assured piped water supply in schools, anganwadi centres and ashramshalas (residential schools in tribal areas), a '100–days' campaign has been launched on October 2, 2020, which will help in ensuring clean water to our children for their better health and holistic development. In this backdrop, it has been decided to convene a virtual conference of Ministers in-charge of rural water supply of all States/ UTs on **03.11.2020, Tuesday from 10:00 AM to 01:30 PM over Video Conference**, which will be chaired by the Hon'ble Union Minister, Jal Shakti.

2. In this connection, Hon'ble Union Minister, Jal Shakti has written to your Minister in-charge of rural water supply (**copy enclosed**). You are requested to kindly bring this to the notice of your Minister with a request to participate in the aforesaid conference.

3. The tentative programme of the virtual conference is annexed. You may kindly appreciate that Ministers of more than 30 States/ UTs will be attending the conference and keeping this in view, it has been decided that no written speech will be read in the conference. Kindly brief the Hon'ble Minister with a request to put forth important points, which are of common interest to all the participants and helpful in the meaningful implementation of JJM. To every State/ UT, 5 minutes has been allotted. In case, there is any State specific issue and/ or State/ UT wants to highlight any achievement, the same may be sent in advance, which will be considered and/ or also shared with other States/ UTs for their benefits, if necessary.

4. You are also requested to kindly attend this conference along with your officials as it will help in the implementation of JJM with speed, scale and skill, as well in accordance to the operational guidelines for the implementation of JJM to ensure assured water supply through tap water connection in every rural household including schools, anganwadis, ashramshalas, etc. to improve quality of life of people living in villages especially women and children.
