- (ii) With five years service in the grade rendered after appointment thereto on a regular basis in the PB-3, Rs.15600-39100 + 6600 Grade Pay (Pre-revised scale of pay of Rs.10000-325-16500/-) or equivalent. in the parent cadre or department; and
- (b) possessing the following educational qualifications and experience :
- (i) Degree in Civil Engineering of a recognized University or Institute or equivalent.
- (ii) Master's Degree in Public Health Engineering of a recognized University or Institutions or equivalent: and

- (iii) Ten years' experience in investigation, design construction and operation of water supply and sewerage installations including at least three years in rural sector with experience in desalination, defluoridation, iron removal, water harvesting structures.

The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation (including short-term contract).

Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.

- (ii) with 5 years' service in the grade rendered after appointment thereto on a regular basis in PB-3, Rs.15600-39100/- + 5400 Grade Pay (Pre-revised scale of pay of Rs.8000-275-13500/-) or equivalent in the parent cadre or Department;
- (iii) with eight years' service in the grade rendered after appointment thereto on a regular basis in the PB-2, Rs.9300-34800 + 4600 Grade Pay (Pre-revised scale of pay of Rs. 6500-10500) or equivalent in the parent cadre or Department; or
- (b) possessing the following educational qualifications and experience :-
- (i) Degree in Civil Engineering of a recognized University or Institute or equivalent.
- (ii) Master's Degree in Public Health Engineering of a recognized University or Institutions or equivalent: and
- (iii) Five years' experience in investigation, design construction and operation of water supply and sewerage installations including one year in urban sector

or rural sector with experience in desalination, defluoridation, iron removal, water harvesting structures.

Note: Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation (including short-term contract/absorption shall be not exceeding 56 years as on the closing date of the receipt of applications.

While forwarding the applications of the officers, it may also be certified that the service particulars of the officers have been checked and found correct as per records available with them and a certificate in this regard may also be sent to the Department. The applications received without complete and up-to-date CR Dossiers, vigilance and integrity certificate and a list of major/minor penalties of the officers will not be considered. Once the nominations of the officers are received, they will not be allowed to withdraw their nomination later.
