2. In terms of the notified Recruitment Rules for the post of Deputy Adviser (PHE) the educational qualification, experience and age limits etc. required for Deputy Adviser (PHE) shall be as under:

II. Officers under the Central or State Governments or Union Territories or Autonomous Bodies or Public Sector Undertakings or Statutory Organizations or Universities or Recognized Research Institute:

- (a) (i) holding analogous posts on regular basis or equivalent in the parent cadre or Department; or
- (ii) with five years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs.10,000-15,200 (pre-revised) or equivalent in the parent cadre or department; and
- (b) Possessing the following educational qualification and experience:
- (i) Degree in Civil Engineering of a recognized University or Institute or equivalent.
- (ii) Master's Degree in Public Health Engineering of a recognized University or Institutions or equivalent;
- (iii) Ten years' experience in investigation, design construction and operation of water supply and sewerage installation including at least three years in Rural Sector with experience in desalination, defluoridation, iron removal, water harvesting structure.


- II. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation (including short-term contract).

Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of Central Government shall ordinarily not to exceed four years. The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.

3. It is, therefore, requested that service particulars and bio-data of the eligible officers who are willing to be considered may please be sent to this Department in the prescribed proforma (in triplicate) enclosed (Annexure-I) along with their complete and up-to-date CR Dossiers (for the last five years) and Vigilance Clearance, Integrity Certificate and a list of major/minor penalties (Annexure-II), if any imposed upon the officer during the last 10 years in the prescribed format as at Annexure II, so as to reach this Department latest by 45 days of publication of this circular in the Employment News/Rojgar Samachar. While forwarding the applications of the officers, it may also be certified that the service particulars of the officers have been checked and found correct as per records available with them and a certificate in this regard may also be sent to the Department. The applications received without complete and up-to-date CR Dossiers, vigilance and integrity certificate and a list of major/minor penalties of the officers will not be considered. Once the nominations of the officers are received, they will not be allowed to withdraw their nomination later.
