Madam/Sir,


I am directed to forward herewith a copy of NITI Aayog (SJE & VAC Division) Office Memorandum No.M-11/(13)2/2020-VAC dated 21st July, 2020 regarding the above mentioned subject, which is self-explanatory, for taking necessary action for compliance.

2. As per the Operational Guidelines of Swachh Bharat Mission (Grameen) [SBM(G)] Phase-II, a Centrally Sponsored Scheme, starting from preparation of annual action plans and project implementation plans under this programme, the NGOs/CSOs/VOs, etc can be involved in various activities such as IEC and capacity building, verification of ODF Plus villages, setting up Rural Sanitary Marts to ensure quality bulk supply of hardware for toilet and solid and liquid waste management infrastructure, assisting GPs in creation and operation & maintenance of Solid and Liquid Management infrastructures, etc.

3. All States/UTs are, therefore, requested to ensure that all the NGOs/CSOs/VOs etc. involved with SBM(G) must register on the NGO Darpan Portal of NITI Aayog and produce the unique ID issued by NGO Darpan Portal to the State Implementing Departments. It is also requested that credentials of such organisations may also be verified on NGO Darpan Portal through the Unique ID. Action Taken Report may also be furnished to this office at the earliest.

Subject: Request to ensure Unique ID of NGO Darpan Portal mandatory under Centrally Sponsored Schemes and to provide list of Central Sponsored Schemes in which Grants-in-Aid component is involved – regarding

The undersigned is directed to invite your kind attention to the subject mentioned above. In a meeting chaired by the Adviser (Shri Amarjeet Sinha) to Hon'ble Prime Minister, it was decided to ensure that NGOs/CSOs taking grants from States/UTs under Centrally Sponsored Schemes should also register/sign-up on NGO Darpan Portal.

2. It is noticed that the Central Ministries/Departments release funds under Centrally Sponsored Schemes to States/UTs in which certain components are implemented through the NGOs/CSOs/VOs etc. Some of the NGOs/CSOs have not registered on NGO Darpan Portal of NITI Aayog.

3. In view of the above, the Central Ministries/Departments are requested to issue requisite instructions to the State Departments to ensure that NGOs getting grants under Centrally Sponsored Schemes must register on NGO Darpan Portal of NITI Aayog and produce the unique ID issued by NGO Darpan Portal to the Departments implementing Centrally Sponsored Schemes and these departments may also be instructed to verify the credentials of NGOs/CSOs/VOs etc. on Darpan Portal.

4. You are also requested to arrange to furnish the list of Centrally Sponsored Schemes under which certain components are implemented through CSOs/NGOs/VOs etc. and also a line of action taken in this regard may kindly be arranged to furnish to this Office at the earliest.

5. This issues with the approval of the competent authority.
