**Progress in Swachh Bharat Mission- Grameen Phase-II**

During April, 2021, 1,05,501 Individual Household Latrines (IHHLs) and 3,256 Community Sanitary Complexes (CSC) have been constructed. An amount of Rs. 11.97 crore has been released to States under the programme during the month.

**Progress in Jal Jeevan Mission (JJM)**

During the month of April, 2021, 9,17,798 households have been provided with Functional Household Tap water connections.
