## Government of India Ministry of Jal Shakti Department of Drinking Water & Sanitation

Subject: Monthly summary for the month of December, 2023 in respect of Department of Drinking Water and Sanitation.

## I. Jal Jeevan Mission (JJM)

26.67 lakh households were provided with functional household tap water connections, taking the total number to 13.88 crore. An amount of Rs 11,115 crore was released to the States/UTs during the month.

## II. Swachh Bharat Mission - Grameen- Phase - II

3,64,869 Individual House Latrines (IHHLs) and 958 Community Sanitary complexes (CSCs) have been constructed during the month of December 2023. 14,861 villages reported to have been covered with Solid Waste Management and 19,229 villages reported to have been covered with Liquid Waste Management during the month.

20,556 villages have declared themselves ODF Plus, taking the total number to 5,14,140 out of 5,91,758 inhabited villages. An amount of Rs. 735 crore was released to the States/ UTs during the month.

- III. A meeting was taken by Secretary, DDWS on 4th December, 2023 to assess the progress and implementation of JJM in all States/ UTs. All the senior officers from the States/ UTs attended the meeting.
- IV. Secretary, MoPR, Secretary, MoSDE and Secretary, DDWS jointly chaired a VC meeting with state Secretaries of all three departments, on 8th December, 2023 to review the implementation of Nal Jal Mitra programme under Jal Jeevan Mission.
- V. Secretary, DDWS took a meeting on 14th December 2023 to assess the provisioning of adequate water supply under the JJM in all the Particularly Vulnerable Tribal Groups (PVTG) households for the PMJANMAN programme for development of PVTGs.
- VI. Secretary, MoRD, Secretary, MoPR and Secretary, DDWS jointly held a VC meeting with state Secretaries of all three departments, of all the States/ UTs on 18th December 2023 to discuss the convergence issues of 15th Finance Commission, MNREGS and other schemes of Central/ State Government in the implementation of SBM (Grameen) and JJM.
- VII. Joint meeting with DFS, MNRE, MoPNG, PSU banks and CBG operators were held on 19th & 20th Dec. 2023 through VC under the Chairmanship of Joint Secretary and Mission Director –GOBARdhan to review issues related to bank financing being faced by CBG plant proponents.

- VIII. A round table conference with RWPF Partners was held on 22nd December, 2023 in Conference Room, 4th Floor, Pt.D.D.Antyodaya Bhawan, CGO Complex, New Delhi. The meeting was chaired by the Joint Secretary and Mission Director SBM(G), DDWS, Ministry of Jal Shakti. 8 RWPF Partners have attended the Conference.
- IX. Review meeting held on 26th Dec.2023 with DFS, MNRE, MoPNG, DoF, DA& FW and MoHUA under chairmanship of Joint Secretary and Mission Director, GOBARdhan to review the progress on various issues pertaining to stakeholder Ministries/Departments.
