Subject: Revalidation of data and allowing entry/ updation of the information about piped water supply schemes already approved by SLSSC under erstwhile NRDWP – regarding

Madam/ Sir,

The undersigned is directed to state that the matter regarding entry of information in JJM - IIMS related to piped water supply schemes taken up under erstwhile NRDWP, which could not be entered/ modified due to certain restrictions, has been examined. In this regard, attention is invited to the Operational Guidelines for the implementation of the Jal Jeevan Mission, wherein village level planning is to be done and based on the same District and State plan, both annual and five year plans are to be prepared. Further, quarterly and yearly targets for FHTCs are to be firmed up so as by 2024, all households are provided with FHTCs. As a matter of strategy, to cover all households with provision of FHTCs, augmentation and retrofitting of completed and ongoing schemes under NRDWP taken up earlier are to be accorded priority. All such schemes are to be monitored online through JJM-IIMS and therefore:

- i.) States are requested to prepare a consolidated list of such piped water supply schemes taken up under erstwhile NRDWP with the approval of SLSSC but could not be entered into the IMIS, and can be retrofitted/ augmented to provide functional household tap connections as prescribed in the Operational Guidelines of JJM.
- ii.) Further, States may also prepare a list of schemes already entered in IMIS, where inadvertent mistakes were made while entering the scheme related data and rectification is required.
- iii.) Same may be entered or modified in IMIS after obtaining prior approval of the Secretary/ Principal Secretary of State's/ UT's PHED/ Rural Water Supply Department, on or before 28.2.2020 and may incur expenditure out of JJM fund to complete the scheme to provide FHTCs, subject to conditions that no escalation of cost is allowed

and such schemes are completed as per the time lines prescribed in the JJM guidelines.

- iv.) Further, details of all such schemes to be placed before the next SLSSC/ SWSM meeting for its information.
2. This may be accorded top priority.
