## Madam/Sir,

I am directed to refer DO No. B-12018/04/2015-SDE dated 05.09.2016 received from Ministry of Skill Development & Entrepreneurship (MoSD&E) on above mentioned subject and to say that in order to prepare National Skill Development Action Plan, MoSDE has requested this Ministry to undertake skill gap analysis in rural drinking water sector, estimate skilled manpower requirement and finalize skill action plans.

- 3. There may be multiple schemes IDs (and therefore the scheme data that have been entered into IMIS) corresponding to one scheme, possibly due to provisioning for augmentation or upgrade requirements. Accordingly, states may provide a real picture based on the exact numbers of completed schemes and ongoing schemes.
- 4. The manpower requirement could be of two types and at two different stages. There are in-house PHED Engineers and Contractors workforce. Similarly, the stage of construction and commissioning may result in a different workforce than during the O&M tenure. Hence the above proforma may be filled up based on the prevailing condition in the state.
- 5. In addition to above, it is also requested that a projection of training requirement and broad areas under which the training is to be imparted such as hand pump mechanics, pump operators, civil gangue, FTK sampler etc. may be detailed.
