The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF OLD VEHICLE". The vehicle will be available for inspection between 2:00pm to 4:00pm on 19<sup>th</sup> and 20<sup>th</sup> November, 2018.

The quotations will be opened in the Room of Under Secretary (General), 8<sup>th</sup> floor, Pt. Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi-03. The bidders or their representatives (not more than one for each quotation) may be present, if they so desire, at the time of opening of quotations.


The sale will be governed by the following conditions:-

- I. The bidders are required to pay Earnest Money of Rs. 2000.00 (Rupees Two Thousand only) for the vehicles.
- II. Earnest Money is payable by means of Demand Draft drawn in favour of PAO, Ministry of Drinking Water & Sanitation, New Delhi. (payment by cheque or cash shall not be accepted)
- III. Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
- IV. The successful bidder will be required to deposit the bid amount by mean of Demand Draft drawn in favour of PAO, Ministry of Drinking Water & Sanitation, New Delhi within two working days of the acceptance of the bid.
